Mayor Brown presented a proclamation to seven-year-old resident Rocco Regalbuto for his heroic action of dialing 9-1-1 to save his mother's life.

Mayor Brown presented a proclamation to promote the "Heads Up, Eyes Forward!" campaign, the goal of which is to bring awareness to the dangers of distracted driving.

Mayor Brown presented a proclamation to the Cherokee High School Girls' Basketball Team for a victorious year, having been ranked as the #1 team in South Jersey for the 2016 - 2017 season.

Mayor Brown presented a proclamation to the Marlton Woman's Club for its efforts in child abuse prevention and formally declared the month of April as Child Abuse Prevention Month in the Township of Evesham.

PRESENTATIONS

Tim Staszewski, Township Engineer, presented Phase II of the Willow Bend Road Improvement Plan. Mr. Staszewski explained that this upcoming project will include street repaving, improvements to stormwater drainage, and the replacement of select curbs and sidewalks that represent trip hazards. Most significantly, the plan includes the incorporation of a bike lane.

Mayor Brown called for a motion to approve the plan for Phase II of the Willow Bend Road Improvements.

Township Manager Tom Czerniecki presented the Lenape Regional High School District Tax Levy. Discussion ensued with Township Council. Mayor Brown urged the Evesham Township Board of Education and the Lenape Regional High School District to acquire health insurance through the open market in order to prevent continual school tax increases.

Township Manager Tom Czerniecki reviewed the 2017 Budget, as introduction of the same is planned to take place at the next Council Meeting. Mr. Czerniecki discussed a ratable growth of \$30 million in the last year, though the Township saw a \$34 million reduction in valuation due to tax appeals. Moreover, the Township has maintained stable debt, which leaves the municipality with a capacity for improvements. The purpose of surplus was discussed, with Mr. Czerniecki noting that the Township Council has returned \$247,650 of surplus in tax reductions to the public since 2014. Moreover, the Township continues to maintain an "Aa3" bond rating with a positive outlook. Mr. Czerniecki also noted the significant cost drivers behind the 2017 Budget, which includes the Indian Spring Golf Course legacy costs, the School Resource Officer Program, landfill fees, enhanced snow removal services, and capital program down payments. Out of the surrounding townships, Evesham has the lowest per capita municipal budget. Additionally, out of the ten largest towns in Burlington County, Evesham also has the lowest per capita budget and the lowest tax increase on the average assessed home between 2005 and 2016.

Regarding landfill fees, Mr. Czerniecki clarified that the new Department of Public Works policy, introduced at the Council Meeting of March 7, 2017, was implemented to control the dumping of heavy waste from contractors, not residents. Mayor Brown stated that even then, residents should be getting dumpsters for major construction projects. Councilman DiEnna suggested that the Public Works Facility utilize a scale to control fees for construction waste.

April 4, 2017 Regular Meeting

In reference to the School Resource Officer Program, Councilman D'Andrea expressed his opinion that the Evesham Township School District should cover the costs of the SRO Program in its entirety as the District's budget is larger. Moreover, he noted that this program was meant to be a partner program, in which both the District and the Township split the costs of the same. Since the start of the program, the Township has covered the costs in full. Mayor Brown reflected the same, and requested that Mr. Czerniecki contact the Board of Education to express Council's intentions on the matter.

In accordance with the same, Township Manager Tom Czerniecki expressed that it is also important to note that there are plans to open a part of the Harvest House will be made available to the public. Mayor Brown asked if there were any separations.

Councilman DiEnna separated Resolution No. 102-2017 and inquired about its purpose. Township Solicitor John Gillespie responded that the objective of the legislation is to better keep track of the expenses the Townships incurs on seeking advice in regard to Open Public Records Act requests. Ultimately, the goal is to provide the State legislature with a report reflecting the financial burden OPRA law places on municipalities.

PUBLIC COMMENTS

Ila Vassallo, 5 Beauport Circle, on behalf of the Environmental Commission, respectfully suggested that Township Council consider preserving passive open space throughout the municipality and utilize the open space trust fund for said purpose.

Mayor Brown responded that the Indian Spring Golf Course has used the majority of the open space trust fund, and that due to affordable housing requirements imposed by the State, any open space available to the Township must be utilize to meet those requirements.

Dan Meyers, 12 Arrowhead Drive, stated that the Evesham Township Board of Education has hired a broker to potentially lease the property currently housing the Evans Elementary School building. Mr. Meyers expressed his concern that this may negatively impact the Arrowhead neighborhood.

Mayor Brown stated that the property can only be used for educational purposes, as that is what it is currently zoned for. In order to lease the school building, the Board of Education must come before the Township Council for approval. Mayor Brown and Mr. Meyers discussed what could be done to increase property values in the Arrowhead neighborhood in light of the closing of Evans Elementary School.

Janis Knoll, 304 Elm Terrace, questioned the amount of affordable housing units that will be made available through the Barclay Chase project. Township Solicitor John Gillespie replied that the plan agreed to approximately 33 affordable housing units.

On a separate topic, Ms. Knoll inquired about the relocation of the Harvest House, and the plan for the rest of the property. Mayor Brown responded that the property will undergo redevelopment. Councilman D'Andrea explained that in order to save the Harvest House, it has to be moved to the edge of the property to make room for redevelopment.

PUBLIC HEARING: COMCAST FRANCHISE AGREEMENT

Township Manager Tom Czerniecki introduced Fred DeAndrea, a representative from Comcast, to explain the purpose of the public hearing for the renewal of Comcast's franchise agreement with the Township of Evesham.

Fred DeAndrea noted that the public hearing is required by law, and that there are no formal actions required from Township Council on the same. Before opening the floor to public comments, Mr. DeAndrea discussed what Comcast has done to increase customer service.

Councilman D'Andrea noted his interest in live streaming Council Meetings, and inquired if Comcast would be able to provide the Township with the necessary equipment.

Mr. DeAndrea stated that it is an aspect of the franchise agreement suitable for discussion.

Mayor Brown opened the public hearing on the Comcast Franchise Renewal Agreement.

No comments were made.

STAFF COMMENTS

Tom Shanahan, Director of Finance, reported that the Township refunded its bridge commission loan, which resulted in the saving of \$400,000. Mr. Shanahan presented Township Council with the bond refunding report.

Allison Bittner, Management Assistant/Analyst, announced the launch of the Township's E-Newsletter, "Everyday Evesham," as a part of a new communication initiative. The goal is to provide subscribers with the newsletter twice a month via email.

Chris Chew, Chief of Police, commented on the success of the School Resource Officer program, as these designated officers have been effective in rapidly securing the safety of children and teachers during various incidents that occurred after the inception of the program. Mayor Brown requested that a report reflecting the same should be sent to the members of the Board of Education for consideration.

Tim Staszewski, Township Engineer, stated that Phase II of the Willow Bend Improvement project will begin after July 4, 2017.

Tom Czerniecki, Township Manager, commended Tom Shanahan for his work on the 2017 budget. On a separate topic, Mr. Czerniecki addressed resident Janis Knoll about her comments regarding the Township's website at the Council Meeting of March 7, 2017. In order to facilitate better communication with department managers per her request, Mr. Czerniecki stated that a link has been created to provide a way for residents to directly email the same.

John Gillespie, Township Solicitor, expanded upon Dan Meyer's concerns over the potential leasing of Evans School. Mr. Gillespie noted that Mr. Czerniecki composed a letter to the Board of Education suggesting the various obstacles and possible ramifications of leasing the property, and invited the Board to have a discussion with Township officials on the same. Mr. Gillespie reported that members of the Board of Education failed to respond to Mr. Czerniecki's letter.

COUNCIL COMMENTS

Councilman D'Andrea thanked Eagle Scout, Matt Smith, for the creation of a nature trail connecting Cherokee High School and the Memorial Park as proposed at the Council Meeting of October 18, 2016. On a separate topic, Mr. D'Andrea, in regard to Ila Vassallo's comments on the preservation of open space, stated that if the State didn't impose extensive affordable housing requirements, he would not be in favor of more redevelopment in the municipality.

Mayor Brown presented a handmade book created by the Township's 5^{th} graders, which lists the reasons that they love about living in Marlton.

On motion by Councilwoman Hackman, seconded by Councilman DiEnna, it was moved to adjourn the meeting.
