### **PRESENTATIONS**

Township Manager Tom Czerniecki introduced members from the New Jersey Department of Transportation to discuss future Route 73 improvements. Representatives from the DOT examined the existing conditions of a section of Route 73 (Brick Road to Evesham Road) regarding heavy traffic congestion and corresponding safety concerns. The proposal for future improvements included constructing a third lane in particular areas and included round-abouts to decrease the amount of vehicle congestion.

Mayor Brown inquired as to the start of the project and as to the public's role in the design of the project.

A representative from the DOT responded that they anticipated construction to begin in at least five years, and that the public will get to make suggestions for the design of the new roadway.

### PUBLIC COMMENTS

Rosemary Bernardi, 10 Halifax Court, thanked Township staff for the completion of sidewalks on Willow Bend Road. In response, Township Manager Tom Czerniecki stated that...

Doris Cinkowski, 30 Cooper Avenue, a 70 year resident, expressed frustration at the rising levels of traffic throughout the area, particularly when it comes to redevelopment. Mayor Brown responded that the development of apartment complexes on Main Street will help encourage an increase in foot traffic. Ms. Cinkowski then questioned the future of the Marlton Tavern and Harvest House, as she fears they will be removed during redevelopment. Mayor Brown stated that there are no plans to remove the tavern, and in fact, the building has received permits for expansion. The Harvest House, he continued, will be moved forward in order to make room for redevelopment while preserving the historic building.

Mayor Brown discussed the positives of progress.

Ken Mills, 109 Meadow Lane, expressed his agreement with DOT plans to widen a certain section of 73. However, he noted his

concern that this project may increase cut-through traffic on Meadow Lane.

Marlene Pinelas, 34 Hanover Road, stated her concern over the development of an apartment complex on Evesboro-Medford Road and how the same will have a negative impact on traffic and parking in that area.

Fran Hahn, of 5 Jonquil Place, thanked Council for their guidance in planning a future for the Township, but like others, she is also concerned with vehicular traffic. Moreover, she requested that officers be present on Elmwood Road to help slow the speed of motor vehicles that are operated in excess of the speed limit. Mayor Brown noted her concerns and stated that he will pass on her suggestion to the Chief of Police.

Sharon Cinkowski, 30 Cooper Avenue, expressed her concern for the preservation of historic buildings on Main Street and how they will be affected by redevelopment. Mayor Brown stressed that the Township is not exercising eminent domain over these properties. Ms. Cinkowski then questioned the purpose of the construction of apartments, and the affordable housing aspect of the same. Mayor Brown responded that the redevelopment will increase the tax value of the properties, which in turn will bring greater revenue into the Township. Discussion then ensued on State demands of affordable housing on municipalities.

Marshall Ogan, 59 Weaver Court, discussed Main Street walkability and suggested that redevelopment on the same be viewed as a district. Mr. Hogan also noted that businesses on Main Street are supportive of the development of apartment complexes, as they will bring in more customers, and consequently, more revenue.

Township Manager Tom Czerniecki explained that in 2009, the Township received a grant to do a study regarding the future planning of Evesham. In this process, the public had the ability to contribute opinions and suggestions for the same. In regard to Main Street, Mr. Czerniecki noted that the area was designated in need of redevelopment in order for the Township to incentivize developers to produce higher quality products in the area. Moreover, Mr. Czerniecki noted his support of applying for a similar grant that would allow for public input specifically on the Main Street area.

Mayor Brown stated his willingness to offer short-term PILOT agreements to developers looking to invest in the downtown area of Main Street.

Betty Costello, 18 Evesham Avenue, questioned the amount of apartments that have already been added and the amount that are planned to be constructed in the future. Director of Community Development Nancy Jamanow responded accordingly.

Mayor Brown noted that as per redevelopment agreements, new apartment complexes cannot be built until the previous is at 75% capacity. This, inevitably, will slow the rate of the construction of the same, and may convince redevelopers to build commercial properties instead. Ms. Costello then questioned State affordable housing requirements. Mayor Brown briefly explained that the State demands that any redevelopment project must have a certain percentage of low income housing. Discussion ensued further. On a separate topic, Ms. Costello noted that the brick walkway in front of the Fire Station on Main Street is in need of repair.

## STAFF COMMENTS

Mary Lou Bergh, Township Clerk, wished Acting Deputy Clerk Caitlin Midgette good luck in her future endeavors.

Township Manager Tom Czerniecki asked Council for a special meeting on September 19, 2017 at 4:00PM to adopt a resolution awarding a contract for the 2017 road improvements project.

Township Solicitor John Gillespie further explained the State affordable housing requirements and what they mean for future redevelopment in the Township. Mr. Gillespie, in response to traffic complaints made earlier during public comment, stated that all redevelopment plans include a traffic study.

On a separate topic, John Gillespie requested a motion to apply eminent domain proceedings on the Burger King in the Tri-Towne area to ensure fruition of the redevelopment plan. He stressed that the Township, in good faith, tried to negotiate with Burger King on the matter. Moreover, the eminent domain proceedings will not be funded by taxpayers - all costs will be paid for by the developer of the Tri-Towne project. Discussion ensued.

On motion by Councilwoman Hackman, seconded by Councilman DiEnna, it was moved to pursue eminent domain over the Burger King in the Tri-Towne area.
